Monroe County Medical Society is currently seeking nominations for its 2021 Edward Mott Moore Awards. This highest honor bestowed annually by the Medical Society is given to both a physician and a layperson in recognition of outstanding and dedicated service to the medical profession and the community.



EDWARD MOTT MOORE, M.D.

Edward Mott Moore was devoted to the alleviation of human suffering. His influence for good in our community was quiet, constant and effective. Through this award, Monroe County Medical Society seeks to recognize those in our community who most closely emulate the breadth of service reflected in the life of Dr. Moore.

Dr. Moore was a prominent surgeon, outstanding teacher, investigator, leader and contributor to the Rochester community, where he resided. He was president of the Monroe County, Central New York, and New York State medical societies; the American Medical Association; the American Surgical Association; and the New York State Board of Health. He headed the St. Mary's Hospital staff for nearly a half century. For many years, he served as president of the board of trustees of the University of Rochester. Dr. Moore was instrumental in establishing the Rochester City Hospital and the Infant's Summer Hospital. His later years were devoted almost exclusively to the development of Rochester's park system.

Award Specifics

Recipients will receive a plaque and recognition at the MCMS Annual Meeting in May. Recipients will also receive recognition in the MCMS physician journal, The Bulletin, and on the Medical Society's website.

Who Can Make a Nomination

Any individual or group may submit nominations. Nominations submitted in prior years may be resubmitted.

Nomination Process

All nominations require:

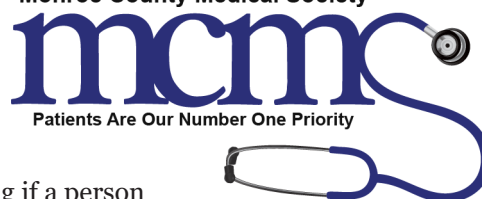
- a completed nomination form
- three or more letter(s) of support providing details on how the nominee meets the award criteria;
- an overview of nominee's achievements;
- a current CV or similar biographical sketch of the nominee.

Nominations may also include: newspaper clippings, copies of certificates and other relevant supporting documentation.

Selection

The MCMS Awards Committee reviews all nominees at their yearly meeting and recommends one candidate for the physician award and one candidate for the layperson award, to the Board of Directors. The Board reviews the recommendations and, if found to represent the highest standards of the Society, approves the candidates. Approved candidates are contacted by the MCMS executive director by mid-April.

When determining if a person should receive the Edward Mott Moore Award, consideration will be given to the following criteria:

Length of service to the community:

This individual's contributions have been made over a significant length of service.

Level of results:

This individual has made an outstanding contribution to the community that is beyond the normal scope of their duties and professional responsibilities.

Effort:

This individual has demonstrated breadth and depth in effort and spirit.

Impact on patients or the profession of medicine:

This individual merits recognition for distinguished service in advancing and promoting the health and well being of the people of our community.

Monroe County Medical Society seeks to recognize individuals whose achievements in these criteria are outstanding, recognizing that nominees may demonstrate more strength in some criteria than in others.
